

C.S.H.A. SHOW OF CHAMPIONS STALL RESERVATION RULES

STALL RESERVATION FEE - \$10 PER STALL (horse or tack)

Postmark deadline date for the form and payment is

**August 5th
(no exceptions)**

1. Companion equines are not allowed. Only equines entered in competition and/or used by the State Patrol will be allowed on the grounds.
2. Each potential competitor, including Horsemastership and Royalty, who will require a horse or tack stall must submit a completed Stall Reservation form and pay a deposit for each stall on the form.
3. **One competitor per form.**
4. The refundable deposit **MUST** be included with the form (see rule 16 for refund instructions). **Except for members of the same family - one check per form.**
5. Each potential competitor, including Horsemastership and Royalty, is responsible for paying their own deposit.
6. The Stall Reservation form is separate from the entry form. Paying the full stall fee on the entry form and mailing the entry form postmarked by August 5th does **NOT** constitute having paid a stabling deposit.
7. Except for Horsemastership and Royalty contestants reservations will **not** be accepted if made in the name of a Region or program.
8. Forms received after the deadline date will be returned. This includes add-ons to a reservation that was postmarked by the deadline date.
9. **DEPOSITS (horse stall, or tack stall) WILL NOT BE TRANSFERRED TO ANOTHER COMPETITOR.**
10. **Tack Stalls-** A deposit must be paid for each tack stall. **The reservation must be in the name of a competitor.** A reservation for a shared tack stall must be in the name of the competitor who will list the tack stall on their entry form. If a shortage of stalls occurs, tack stalls may not be available.

11. **On the entry form there are two stall fees.** Stall Fee #1 applies only to the stalls for which a deposit was paid by the postmark deadline date.
- a. If a Stall Reservation form and Stabling Deposit were not submitted by the postmark deadline date above, Stall Fee #2 must be paid.
 - b. On the entry form, there will be a space to deduct the deposit paid from the total stall fee.

12. Additional stalls listed on the entry form, are not eligible for Stall Fee #1.

13. The stall fee is a flat amount for the show.
14. If a shortage of stalls occurs, competitors who did not submit a Stall Reservation form, with payment in full by the deadline date, may be assigned a stall off the grounds.
15. Every division, including Horsemastership and Royalty, has an entry form. If an entry form is not received by September 20th the reserved stall will be reassigned.
16. **If you do not attend the show, to receive a refund you must submit a Refund Request form. The request must be postmarked no later than October 20th.**
